HISTORY:

Mount Olivet Rolling Acres (MORA) founded the Metro Crisis Coordination Program (MCCP) in 1996 as part of a collaborative effort among the counties of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington.

GOALS:

- To prevent crises affecting residential, work and/or educational placements of people with intellectual disabilities or related conditions.
- To provide timely behavioral consultations and assessments.
- To operate in conjunction with existing services.
- To reduce the need for psychiatric hospitalizations and allow people to successfully remain in the community.

SERVICES:

- Preventative behavioral interventions, assessments, and crisis support planning.
- Technical assistance and training to Families, Day Programs, Schools, Residential Programs, and Care Providers serving individuals with intellectual disabilities or related conditions.
- 24-hour emergency telephone consultation, call 612.202.6311.
- Maintenance of a centralized database of additional behavioral support services afforded to individuals with intellectual disabilities or related conditions (ID/RC) and those who support them.
- Coordination of transitional housing and staff or care provider augmentation.
- Potential for a one time psychiatric consult.
- When indicated MCCP will help facilitate the referral process for more extensive or specialized services if necessary. MCCP actively supports and refers individuals and providers to long-term behavioral assessment and support services provided by private and public agencies.
- Provide large group trainings to group homes, schools, day programs, county agencies, parent support groups and other professional organizations. The trainings are ideal for new staff, skills refreshers, staff training days and staff meetings.

COST:

Services are funded through the referring county. MCCP services are available to all individuals with a qualifying developmental and/or other disability who are the financial responsibility of the seven-county metro area.

PERSONNEL:

MCCP's team includes director, clinical supervisor, behavior analysts, psychiatric nurse, information & referral specialist and staff augmentation specialists. MORA offers administrative support and guidance.

MORA is a private, nonprofit agency and has provided residential and other services to people with intellectual disabilities or related conditions for over 50 years.

Additional support and oversight are provided by a steering committee comprised of personnel who serve people with intellectual disabilities or related conditions from the seven metro county sponsors.
